Terms and Conditions

- A deposit is required to book your place (please see individual course details for the amount payable). The final balance is due no later than 14 days prior to the course start date. Places on any course are not guaranteed until a booking confirmation/receipt is sent by Repton School Enterprises
- 2. An early payment discount applies to some courses (please see individual course details for further information). This is in recognition of our reduced costs where bookings are made and paid in full in advance. To qualify the full sum must be paid in a single payment by the date stated.
- 3. Multiple Booking Discount of 10% will be applicable on second and subsequent bookings when made in a single transaction. The discount will apply to the cheaper of the courses.
- 4. Cancellation of non-residential bookings within 7 days and residential bookings within 14 days of the course start date will result in the loss of your full fee. Full sum less £15 admin charge will be refunded for cancellations made more than 7 days for non-residential bookings or 14 days for residential bookings respectively before course begins.
- 5. Your child may be excluded from the course if, in our opinion, his/her presence is detrimental to the well-being of other students, in which case no refund will be given.
- 6. Any concern or complaint about any course or any aspect of the course, should be addressed immediately in writing to the Repton School Enterprise Director.
